The Better Business Bureau recommends taking time to research any company before making a decision. A reputable security provider will encourage you to compare options, answer your questions, and allow you time to review the agreement before signing.

Watch for These Red Flags

- High-pressure sales tactics or "today only" offers
- Claims that your current security company is going out of business or that your system must be replaced immediately
- Prices that seem too good to be true
- Representatives who cannot provide company identification or proof of licensing
- Requests to sign a contract before you've had time to review the details



Before You Sign

When considering a new security provider:

- Verify the company through the Better Business Bureau and state licensing agencies.
- Obtain multiple quotes and compare systems, monitoring, and service agreements.
- Review contract terms carefully, including monitoring commitments, cancellation policies, and equipment ownership.
- Ask whether employees have undergone background checks and professional training.
